**Foods:** Meals at Cedar Lodge are served family style and are nutritious and ample. Locally grown foods are used whenever possible. Milk, water, and a substitute beverage are served at every meal. Salads and fresh fruits are always available. Those campers on a full vegetarian diet must be so-noted on the "special needs" form and will be supplied with an adequate meal selection.

**Medical:** Cedar Lodge maintains a full time medical officer on the camp staff to take care of the daily medical needs of all campers. There is no charge for this service. Camp families are responsible for any additional medical expense incurred by their camper due to illness or accident while at camp. We require the information of your insurance carrier and policy number on our Camp Health Form.

A deposit of **\$100.00 for each week** reserved must accompany this application. The balance of the tuition is due by May 1<sup>st</sup> 2019. Payment plans available. This tuition includes room, board, laundry and all camp activities taking place on the camp grounds. All Applications received after May 1<sup>st</sup> should be accompanied by full payment

### DISCOUNTS ON SUMMER CAMP FEES:

**Siblings:** If more than one child attends Cedar Lodge from the same family, each additional child will receive a 5% discount on camp fees.

#### Early Registrations (*applies only to camp fees*):

Applications received before December 1, 2018 paid in full receive a 10% discount.

Applications received before January 15<sup>th</sup>, 2019 paid in full receive a 5% discount.

Applications paid in full by March 1st receive a 3% discount.

\_\_\_\_\_ **Senior Unit** - A special work oriented program for 15 & 16 year old campers. Minimum four week stay. 15 year old campers may qualify for a 15% discount; 16 year old campers may qualify for a 20% discount. Contact for more information.

\_\_\_\_\_ **Camper Horse Board** - Camper boarded horses: \$300.00/week. Price includes board and full riding program fee as long as horse is used by camper in riding class. Contact for more information.

## **CEDAR LODGE POLICY on Payments, Cancellations, Early and Late Arrivals:**

**Refunds will be made as funds are available and no later than the beginning of camp.**

**Payments to Cedar Lodge: Payment through check:** Payment can be for a deposit, full amount or partial payment as long as full payment is made by May 1st. Make out to "Cedar Lodge" and sending it to the camp address on the front of the application.

**Payments through Credit Cards; we are set for most common credit cards:** ALL Credit Card payments will be charged an additional 3.5% to cover credit company charges to us or 3.0 through paypal. We can take cards: 1) On line-through paypal and through a click and pay invoice that we can send you. Either contact us for credit card or paypal invoice, or "send us money" through paypal using [campcedarlodge@gmail.com](mailto:campcedarlodge@gmail.com) 2) Phone us-we can take your information off the phone. 3) Swipe your card when you get here (only applies to weekends, or in-camp payments, as camp balance is due by May 1<sup>st</sup>).

- International Payments:** Cedar Lodge can receive wire transfers. Please send us more information.

**Until March 31<sup>st</sup>:** Any payments made, less \$100.00 cancellation fee, is refundable.

**From April 1<sup>st</sup> to May 1<sup>st</sup>:** Deposit is non refundable. All other payments made, less a \$100.00 cancellation fee (in addition to deposit amount), are refundable.

**After May 1<sup>st</sup>:** No refunds for cancellations or no shows.

**-Payment must be paid in full by May 1st.** Payment plans available upon request.

**-A fee of \$25.00** will be billed for all returned checks.

**-Any applications that are posted after May 1<sup>st</sup> must be accompanied by payment in full.**

**-There will be no refunds made for a camper leaving camp during any camp session, including for reasons of homesickness or misbehavior, except with the written verification of a physician of an injury or physical illness AND if the director and camp Health Officer agree it is in the child's and camp's best interest that the child leave camp.**

**-There will be no refund for early departure if a parent decides to remove their son or daughter from camp against the director's advice.**

**-Any camper or staff member found using alcohol, marijuana, or non-prescribed drugs on the camp's grounds or on field trips will be sent home immediately. No refunds will be issued. Any prescribed medication that a camper brings to camp must be given to the Camp Health Director, in the original prescription bottle and be a current prescription in the camper's name.**

**-There is no reduction in fees for those campers arriving late or leaving early. In case of serious illness or injury, one half of the non-expired camp fee will be refunded, or applied against further camp seasons.**
